Guidelines and Schedule for Special Spot Round of counselling for admission in to MBA Program at IGDTUW:

1. Schedule and Venue: 14th September, 2026 (Monday), Room No. 3, Department of Management, IGDTUW, Kashmere Gate.

Reporting Time: 12:00 PM.

2. Eligibility Criteria: As per MBA Admission Brochure 2026-27.

3. Seat Allotment:

Note: - Admissions is open for candidates not having any CAT/MAT/CUET score. The criteria for seat allotment will be as follows:

First, the seats will be allotted as per the rank of the candidate in the merit list prepared by CMAC-2026 to the present candidates from the merit list.

If seats remain vacant after exhausting the available candidates from merit list of CMAC -2026 seat allotment will be done as per the following criteria:

(I) First, candidates with valid CAT 2025 score will be ranked as per their CAT Percentile and will be allotted seat.

(II) After exhausting the candidates with valid CAT score, candidates with valid MAT score will be given seat as per their MAT percentile.

(III) After exhausting the candidates with valid MAT score, candidates with valid CUET-PG 2026 score in paper General Paper (MBA etc.) (COQP12) will be given seat as per score of General Paper (MBA etc.) (COQP12).

(Note: Candidates with negative score will not be considered in the Merit List).

(IV) After exhausting the candidates with valid CUET PG 2026 score, if seats remain vacant, candidates will be allotted seat as per the percentage in Graduation (Subject to Minimum Eligibility Criteria for MBA given in MBA Admission Brochure 2026).

4. Fee to be paid at the Time of Admission:

Every student who gets the admission offer in the MBA program in any Special Spot Round of Counselling shall pay the course fee (AY 2026-27) Rs 1,48,000/- (One Lakh Forty-Eight Thousand Only) to confirm the admission through NEFT, net banking or DD. The newly registered candidates will also pay Rs. 1500/- as registration fee. Already registered candidates through CMAC need not to pay registration fee of Rs 1500.
