#### FIRST ROUND OF SEAT ALLOTMENT AND ONLINE FEE PAYMENT

All candidates who are allotted a seat in any university during the first round of counselling of MBA (IEV) Admission 2025 held on 19<sup>th</sup> August 2025 are required to pay the **Part Admission Fee of** ₹1,00,000 (Rupees One Lakh) to block the allotted seat using the payment link shared as https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=6811616 or by NEFT: A/c Name: CMAC 2025 A/c No. 43932843352 Branch: DCE branch IFSC code: SBIN0010446

This payment is mandatory and must be completed within the **extended stipulated timeline i.e.**, **by 20 August 2025 (Wednesday), 05:00 PM** (Those who have paid fees may ignore this). Admission will be confirmed once the payment is received in DTU Bank Account. In case of non-payment of seat blocking fees, the seat will be considered as vacant for Spot Round.

### **Important Instructions:**

- Failure to pay the Part Admission Fee within the stipulated time will lead to automatic cancellation of the allotted seat.
- All candidates are requested to carefully follow the steps below to complete the payment of the MBA(IEV) seat blocking fees:
  - i. Click on the link provided above.
  - ii. Under Institute Name, select: DTU CONSULTANCY A/C
  - iii. Under State of Corporate/Institution, select: All India
  - iv. In the Payment Category, select: Seat Acceptance Fees.
  - v. In Course name, select MBA-IEV, and enter other payment details
  - vi. Proceed to make the payment as per the instructions shown on the screen.
- After successful payment share the payment proof by email (ignore if already submitted) on mbaadmissions@dtu.ac.in

The provisional list of candidates who are allotted seats in first round of counselling held on 19th August 2025 is enclosed.

### Withdrawal Policy:

If any candidate wishes to withdraw from admission after paying the Part Admission Fee, they must email application for withdrawal, copy of cancelled cheque, and allotment letter to mbaadmissions@dtu.ac.in.

All fee refunds of the candidates, who have withdrawn their seat till the date of spot round, will be made by CMAC, Delhi 2025 as per the withdrawal policy of the respective University from where withdrawal is taken. After the date of spot round, the candidates have to approach the respective allotted Universities for any withdrawals.

Note: No refund will be done for those who will take admission in Spot round.
