### (MBA) Programme

The Master of Business Administration (MBA) programme is designed to help students become better leaders and managers of enterprises in the twenty-first century. The program's main goal is to impart comprehensive business knowledge, effective communication skills, strategic problem-solving abilities, networking abilities, time and resource management abilities, analytical abilities, and leadership capabilities. Students will be able to develop decision-making skills and enhance their capacity for creative problem-solving because of the course's strong business practice focus. The MBA programme covers a variety of business disciplines, including accounting, finance, marketing, human resources, operations, and decision science. 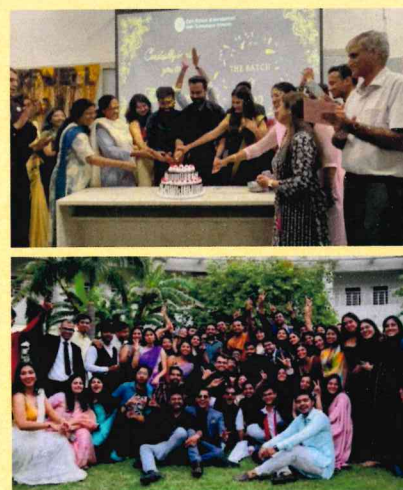
### Orientation'22

Professor

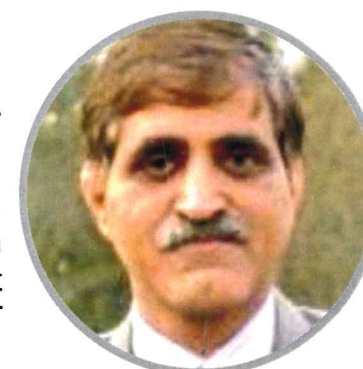

The USME was established in East Delhi Campus (EDC) of DTU in the year 2017, to fulfill its mission of offering a portfolio of the highest quality of programs aimed in emerging areas such as analytics and venture development, and the creation of an ecosystem for learning, research, and practice in management and entrepreneurship. Its center of excellence in Entrepreneurship Development is aimed at helping USME become a nodal center for entrepreneurship and help in enabling all students at the Campus evolve by experiential participation in its new ventures to become a multidisciplinary practice-oriented business managers.

Its mission is to provide cutting edge programs in emerging areas of business, for instance the most recent launch of the Executive MBA program in Data Sciences and Analytics, in USME, was designed by faculty with industry experience, and has a Program Committee drawn from the DTU Computer Science, IT and SE departments along with USME, and will help build a strong community connect with practitioners in the analytics industry specifically.

The USME comprises faculty in three disciplines of Management, Economics and Innovation, Entrepreneurship, and Venture Development, with faculty having a background of leading premier institutions such as the IIMs (Calcutta, Lucknow), the IITs (Delhi, Madras, Kharagpur), the FMS, Delhi University, JNU, New Delhi; Delhi School of Economics (DSE) etc. Most faculty also have critical work experience in industry and government, and the community also has five senior Visiting Faculty who are drawn from industry, with experience in leading firms to help bring a practice focus and enhance industry connect.

As a part of the facilities at East Campus there is a Training and Placement Centre that works in close collaboration with the DTU Training and Placement Department and also takes up a lot of initiatives at the East Delhi Campus based on the needs of the large group of corporates who engage with the over thirteen hundred management and Economics student in the East Campus.

There is a network of student entrepreneurs from the MBA Entrepreneurship streams, and ventures (including the DTU-IIF incubates), mentors and professionals, in-house and visiting faculty from premier institutions and industry, and a vibrant student community. Over 15 incubatees selected at the DTU Incubator, the Innovation and Incubation Foundation (IIF) have been drawn from the East Campus as of date, and many more start-ups have graduated from the premises with high turnovers and profitability.

USME offers degree programs at the UG, PG, and doctoral levels, and also conducts intense workshops on Entrepreneurship, Business Strategy, IT applications and programming such as R for Machine Learning, holds the annual Start-up Conclave, hosts the series of workshops under the University Innovation Council program, and offers career development in various fields like analytics. It actively engages DTU/DCE as well as USME alumni in its activities, such as the MBA Orientation Program, the Career Development programs, amongst many such industry driven interactions, to provide a lot of co-curricular learning.

The cultural fest "Traction", including business contests and many other celebrations of youthful artistic expression in the form of music, dance Nukkad natak, including twenty three clubs in different professional, arts and other interest areas, all contribute to a rich extra-curricular life on Campus.



These activities have drawn students, contestants and participants from across India, including from the IIMs and other premier colleges in Delhi University in the past, and students also participate in many national level festivals and competitions, such as the IIT Mumbai Music fest, etc.

The second USME Corporate Engagement Week, internship fair resulted in over three hundred fifty internship offers to undergraduate and graduate students of USME, with over seventy companies participating in the multi-University event collaborating with NSUT, IGDTUW and Ambedkar University. This will be extended fully to the PG level internships in this coming session. The placement of MBA and UG program candidates is also carried out through the Central DTU Training and Placement Cell, where last year, nearly a hundred companies presented final placement

It has added modern classroom infrastructure and discussion spaces, a state-of-the-art library and information center, seminar rooms, and a 200-capacity state-of-the-art Manthan Hall and a digital studio cum classroom for broadcast of hybrid classes.

USME offers the Master of Business Administration (MBA) program, the MBA (Business Analytics), MBA (Family Business & Entrepreneurship), an MBA (Innovation, Entrepreneurship & venture development) programs. At the UG level, Bachelor of Business Administration (BBA), Bachelor of Arts (BA(H)) in Economics are offered. There are over one thousand three hundred students on the USME Campus at present.

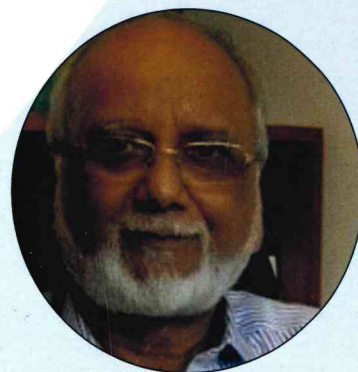


## **DISCIPLINE: ECONOMICS**

## TRAINING AND PLACEMENT

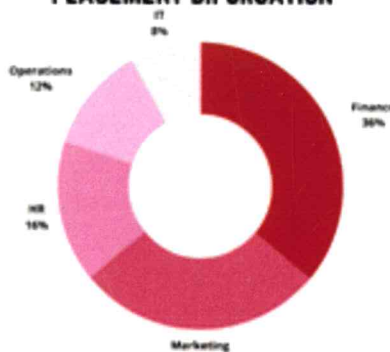

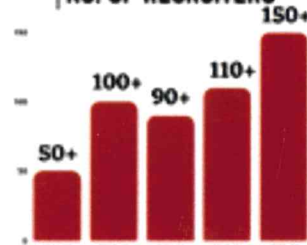

## COURSE CURRICULUM OF MBA

MBA Program is a two-year full time professional program spread over four semesters, which combines rigorous academic schedules with proactive efforts to develop new perspectives and a higher level of knowledge and understanding.

The Program focuses on inculcating effective managerial and leadership skills. The first year of the program offers core courses to develop the right attitude, knowledge and skills which are essential for a leader in the long term. The elective courses offered in the second year give students an opportunity to delve deeper in their respective areas of specialization and thus cater to the role and sector specific career objectives.

## ADMISSION PROCESS, CMAC-2023

Delhi School of Management (DSM) and University School of Management and Entrepreneurship (USME), DTU follows an online process of registration of application for the MBA programme. Centralized Counselling for admission to MBA programme for pioneering universities of Govt. of NCT of Delhi, namely Delhi Technological University (DTU), Netaji Subhas University of Technology (NSUT) and Indira Gandhi Delhi Technical University for Women (IGDTUW) will be conducted through Common Management Admission Committee CMAC, 2023.

Prospective candidates are required to fill a single online application form on the website: [www.dtu.ac.in](http://www.dtu.ac.in) / [www.cmacadmissions.com](http://www.cmacadmissions.com) to participate in the centralized admission under CMAC-2023.

## INTAKE

The annual intake of students in this program is 150 at DSM and 120 at USME.

The reservations of the seats for SC/ST/OBC/EWS and sub categories Defence/ PWD are as per the norms. One seat over and above the total intake in each campus is reserved for Kashmiri migrants. However, there will be no relaxation in the minimum eligibility criteria for Kashmiri Migrants.

## RESERVATION POLICY

- Scheduled Caste (SC):** 15 % of the total seats are reserved for Scheduled Caste candidates.
- Scheduled Tribe (ST):** 7.5 % of the total seats are reserved for Scheduled Tribe candidates.
- Other Backward Class (OBC- NCL):** 27% of the total seats are reserved for Other Backward Class (Non-Creamy Layer) candidates.
- Economically Weaker Section (EWS):** 10% of the total seats are reserved for EWS category as per the office order DHE.1 (119)/Estt./2018- 19/2549-76 dated 17/06/2019  
Sub-categories namely 'Defence' and 'Person with Disability' are available under each category (General, SC, ST, OBC-NCL).
- Defence (CW):** 5% of the total seats (Horizontal) in each main category are reserved for candidates belonging to Defence sub-category in the following order of priority:

**Priority I** - Widows/wards of Defence Personnel killed in action.

**Priority II** – Wards of disabled in action and boarded out from service.

**Priority III** - Widows/wards of Defence Personnel who died while in service with death attributable to military service.

**Priority IV** - Wards of disabled in service and boarded out from service with disability attributable to military service.



**Priority V** - Wards of Ex-Servicemen and serving personnel/para military/ police personnel who are in receipt of the following Gallantry Awards: 1. Param Vir Chakra 2. Ashok Chakra 3. Mahavir Chakra 4. Kirti Chakra 5. Vir Chakra 6. Shaurya Chakra 7. Sena/Nau Sena/ Vayu Sena Medal 8. Mention-in-Despatches 9. President's Police Medal for Gallantry 10. Police Medal for Gallantry.

**Priority VI** – Wards of Ex-servicemen.

**Priority VII** – Wives of:

1. Defence personnel disabled in action and boarded out from service
2. Defence personnel disabled in service and boarded out with disability attributable to military service
3. Ex-servicemen and serving personnel who are in receipt of Gallantry awards.

**Priority VIII** – Wards of serving personnel.

**Priority IX** - Wives of serving personnel

**f) Person with Disability:** 5% of the total seats (Horizontally) in each category are reserved for candidates belonging to 'Person with Disability' sub-category in accordance with the provisions of The Rights of Persons with Disabilities Act 2016' (PwD Act)

**g) Kashmiri Migrants** (Supernumerary): 01 (One) seat, over and above the total intake in each campus of DTU is available under this category.

### **Note:**

- i. In case of category (a) and (b), the vacant seats are interchangeable.
- ii. In case, sufficient numbers of eligible candidates from category (c) are not available, the vacancies will be treated as unreserved.
- iii. Seats under sub-category (f) are interchangeable within the sub category if sufficient number of candidates is not available in a particular group.
- iv. In case, sufficient number of eligible candidates from the sub categories mentioned at (e) and (f) are not available, the vacancies will be reverted to unreserved in the respective category.
- v. Under CW sub-category, the seats will be filled based on the priority, i.e. all eligible candidates of priority-I will be allotted seats based on their ranks until the ranks exhaust or seats exhaust under CW sub category. Remaining vacant seats, if any, will be allotted to the priority-II in the similar way, and so on.
- vi. The reservation under CW sub category is available only to such candidates who fall under the listed priorities.
- vii. It is the sole responsibility of the candidate to prove his/her eligibility for claiming reservation under any of the reserved categories/sub categories. The candidates claiming reservation under SC/ST/OBC/EWS/KM categories, CW/PwD sub-categories will be required to upload scanned copy of the respective certificates and produce the original certificate of the respective reserved category/sub-category issued by the competent authority (as mentioned in this information brochure) in the respective institutes at the time of physical verification of the documents. If the reserved category/ sub-category certificate is not found in order, no benefit of the reserved category/ sub-category will be given and the candidate shall be considered for allotment in GENERAL category in subsequent rounds on submission of written request by the candidate to CMAC in person or email in this regard, as per the eligibility of the candidate and availability of seats.

**If such candidate is able to produce his/her category certificate before the commencement of further round, he/she shall be considered for the category in that round and will be allotted a fresh seat as per the vacancy available and his/her merit.**



viii. After exhausting the complete list of candidates (category-wise) as per prescribed norms, any unfilled seats pertaining to any category may be filled by increasing general category seats, in equal number, during SPOT round of counseling.

## ELIGIBILITY AND ADMISSION PROCEDURE

### 1. Minimum Eligibility Criteria

- a) A candidate who has passed any Bachelor Degree examination with minimum 60% marks in aggregate or equivalent CGPA from a recognised university/institution and valid CAT-2022 /MAT-2022 /MAT-2023 score. However, a relaxation of 10% in marks to SC/ST/PWD candidates shall be given in minimum eligibility criteria.
- b) The student should hold a degree from any of the universities incorporated by an act of the central or state legislature in India, or other educational institutions established by an Act of Parliament or declared to be deemed as a university under section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of Education, Government of India.
- c) Those who are appearing in final semester examination may also apply, provided that they submit:
  - (i) The proof of eligibility by a specific date declared by the University, and
  - (ii) Valid CAT/MAT score at the time of application, otherwise the admission of the candidate to the university will be cancelled.

**In case the conversion formula for CGPA is not provided by the concerned Institute/ University, equivalent percentage shall be computed as per following formula:**  
 **$CGPA \times 10 = \text{Percentage of Marks}$**

**Note: At any stage of the program, if it is found that the candidate does not fulfil the eligibility criteria, his/her admission shall be cancelled and fee shall not be refunded.**

### 2. Selection Procedure

- a) The applications received will be shortlisted based on performance in CAT- 2022/MAT-2022/MAT-2023.
- b) The shortlisted candidates will be required to appear for Personal Interview.
- c) The merit list will first consider the candidates with valid CAT 2022 percentile and after the CAT 2022 candidates are exhausted, the candidates with MAT 2022/ 2023 percentiles will be considered in the merit list. In case any candidate has appeared in both MAT 2022 and MAT 2023, best of two will be taken in consideration.

CAT percentile (rounded upto two decimal places) of 2022 will be considered whereas the best percentile of MAT 2022/MAT 2023 will be considered.

- a) Allotment of University will be done on the basis of '**rank of the candidate**' in the merit list and '**preference of the University**' applied by the candidate.
- b) In case of tie in the final merit list, the following criteria shall be used:
- The candidate with higher entrance test percentile shall be ranked higher (CAT/MAT as applicable).
  - In case of tie in CAT/MAT percentile, the candidate shall be ranked according to the date of birth i.e., the person older in age will be ranked higher.
  - In case of tie in age criterion, random number will be used to break the tie.

## 2 Admission Process

a) The shortlisted candidates will be called for Personal Interview and Document verification in physical mode. The venue and date for the same will be announced on [www.dtu.ac.in](http://www.dtu.ac.in) / [www.cmacadmissions.com](http://www.cmacadmissions.com). The merit list of the eligible candidates will be announced on CMAC website before First round of Counselling.

**NOTE:** The candidates, who do not attend the Personal Interview and document verification process, will not be considered in the merit list.

b) Admission shall be made on the basis of combined merit list prepared on the basis of CAT-2022/ MAT-2022/ MAT-2023 percentile, marks in class 10th, class 12<sup>th</sup>, performance in Personal Interview, and work experience.

c) Provisional Allotment of seat will be done on the basis of rank of the candidate in the merit list and preference of the University applied by the candidate.

### 2.1 Payment of seat acceptance fee

A candidate, who is allotted a seat in any round of counselling is required to pay the part admission fee of Rs. 1,00,000/- (Rs. One Lakh only) as per the payment mode instructed in the guidelines of counselling.

All the candidates who get an allotment will have to pay part admission fee (Rs.1,00,000 – Rupees One Lakh through demand draft) as per the admission schedule, failing which his/her allotted seat will stand automatically cancelled and the candidate will not be considered for subsequent rounds of seat allotment. However, such candidates are eligible for spot round of counselling. Balance fees need to be paid by the candidate in the respective University at the time of academic registration.

Note : If the candidate is allotted a seat in a round and he/she does not pay the required academic fee as per counseling schedule, his/her allotted seat shall be cancelled and he/she will not be considered for any seat allotment in subsequent rounds (except spot round).

### 2.2 Upgradation

After each round of counselling, the candidates who wish to change the University allotted to him/her will be given choice to upgrade to the University of his/her preference subject to the rank of candidate and availability of the seat.

## Certificates required for claiming Reserved Seats

Candidates applying for any reserved seat (i.e. EWS, SC, ST, OBC-NCL, CW, PD, KM) must upload the scanned copy of the certificates (as applicable) as mentioned below at the time filling up of the ONLINE application form.

### **i. Scheduled Caste (SC)/Scheduled Tribe (ST)/Other Backward Class (OBC-NCL):**

For admission to a seat reserved for Scheduled Caste/ Scheduled Tribe/ Other Backward Class (NCL), candidate must produce a certificate, in original, issued from an approved district authority stating the Scheduled Caste/ Scheduled Tribe/Other Backward Class (NCL), to which the candidate belongs. A list of approved authorities is given below:

- a. District Magistrate / Additional Magistrate / Deputy Commissioner/ Collector / Additional Deputy Commissioner/Deputy Collector/ 1st Class Stipendiary Magistrate / City Magistrate (not below the rank of 1st Class Stipendiary Magistrate), Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- b. Revenue Officer not below the rank of Tehsildar.
- c. Sub-Divisional Officer of the area where the candidates and/or his/her family normally resides
- d. Administrator/Secretary to Administration/Development Officer (Laccadive & Minicoy Islands).

### **NOTE:**

1. The candidate seeking admission under reserved categories has to mandatorily upload the caste/ category certificate in his/her name at the time of filling up of the ONLINE form. The certificate in the name of either of the parents (mother/father) or any other family member is not acceptable and the candidate will not be entitled even for provisional admission.

2. OBC (NCL) candidates are required to produce a caste certificate issued after March 31, 2023 from the authorities as mentioned above. However, if the certificate is issued prior to March 31, 2023, it must be accompanied with an additional certificate regarding the present non-creamy layer status of the candidate, issued by the same competent authority. This additional certificate must have reference of his/her already issued original caste certificate. **iii. Kashmiri Migrants:** The candidates seeking admission under Kashmiri Migrants seats must upload the following documents at the time of filling up of the online application:

## IV Economically Weaker Section

**Criteria for Income and Assets** The benefit of reservation under EWS can be availed by persons who are not covered under the scheme of reservation for SCs, STs and OBCs upon production of an Income and Asset Certificate issued by a Competent Authority based upon the following criteria:

Candidates whose family has gross annual income below Rs 8.0 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application. "31<sup>st</sup> March 2023"

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:- i. 5 acres of agricultural land and above; ii. Residential flat of 1000 sq. ft. and above; iii. Residential plot of 100 sq. yards and above in notified municipalities; iv. Residential, plot of 200 sq. yards and above in areas other than the notified municipalities. The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority after March 31, 2023. The Income and Asset Certificate issued 'by any one of the following authorities in the prescribed format as given in Annexure-3 shall only be accepted as proof of candidate's claim as 'belonging to EWS. A list of approved authorities is given below:

- I. District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/ 1st Class Stipendary Magistrate/ Sub Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
- II. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
- III. Revenue Officer not below the rank of Tehsildar and
- IV. Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

### Defence sub-category (CW)

For admission to a seat reserved for Defence sub-category, candidate must produce the following certificates (as applicable), in original, at the time of document verification of Defence candidates.

**a.**Entitlement card in original issued by the Record Officer of the Unit/Regiment of Armed Personnel of the Armed Forces in case of Armed Personnel.

**a.**Widows/ Wards/ Wives of the officers and men of Armed forces who died or were disabled on duty (both attributable to military service) must produce a certificate to that effect from the following authorities.

(i)Secretary, Kendriya Sainik Board.

(ii) Secretary, Rajya / Zila Sainik Board.

(iii) Officer-in-Charge, Record Office.

**b.**Medical records in original.

**c.**Special Pension Order and Passbook indicating special pension.

**d.**Gallantry Award Certificate.

**e.**Original ex-servicemen Identity Card/ Discharge Book/ Pension Payment Order.

**f.**Dependency card issued by the competent authority in order to relate the relationship of the candidate with the Defence personnel.

**g.**Original Service Identity Card.

**h.**A certificate from the respective C.O. Unit in respect of serving personnel.

**NOTE:** A statement to the effect that 'the death/disability is attributed to military service is require to be included in the certificate for Priority III & IV.
